General Membership Meeting  
November 20, 2013

**Pension Committee Report** Dan Melancon reports that the funds on hand as of September 30th is \$2,115,557,000 billion and is 82% funded. The pension fund is in good financial shape.

**Membership Committee Report.** Darrell White thanked everyone for sending in their dues and asked the members to talk to their retired friends and encouraged them to join.

**Healthcare Committee Report** Francis Bradley talked about problems with the vision plan and the once a year exam that requires no co-pay under the medical plan. If there are any problems with the provider, contact Kenya Holmes.

The City's Health, Wellness, and Benefits office published new phone numbers, but they are already changed again. 901-636-6800 is the local number. 866-543-4367 is for out-of-town calls. The numbers are the same but the options have changed.

## **President's Report, Mike Lee**

Mike Lee informed the membership of the following information:

1. The amount of funds raised by the FOP Golf Tournament for the Dream Factory in excess of \$5,000. ACRE donated \$100 to sponsor a hole.
2. The Benefits Office has a Health Clinic at 2714 Union Ext, 5th floor and it is open from 9 am to 1 pm on Monday, Wednesday, and Friday. \$15 co-pay per visit for retirees and dependants. The phone number is 636-6010.
3. On December 31st members who have not paid dues since 2011 will be purged from the membership list. They will not receive a newsletter unless they pay their dues. This will affect 45 members.
4. ACRE will continue to monitor any proposed change in our healthcare benefits.

It should be noted that there were no motions from the floor.

Mike Lee called on James Smith to offer the closing prayer.

The member takes a prescription medication and when he sent off for a refill for 90 day supply they only sent 12 pills and said that was all they were going to send him on instructions from the City. (Frances advised the member to contact the Benefits office for an explanation).
- 2.** One member commented that the city cannot do anything about the pension on those already vested and drawing a pension. But if they increase the cost of healthcare then that does affect our pension. This is what ACRE needs to fight.
- 3.** One member said that many of the older retirees do not have connections to the internet and has to rely on some other means to find out what is going on. (Mike explained that that is why the important information is sent out in the newsletter).
